PURPOSE:

The purpose of this item is to recognize the Maryland schools who received the U.S. Department of Education Green Ribbon Schools award.

HISTORICAL BACKGROUND:

MSDE participated as a lead State Education Agency in the inaugural year of the National Green Ribbon Schools Award program in collaboration with the US Department of Education. MSDE staff members from the Division of Instruction and School Construction were involved in planning and implementing the program since its inception in August, 2011.

MSDE staff developed the application and scoring tool, disseminated information about the award to public and nonpublic schools, collected applications, facilitated the review process, and nominated the maximum of four schools to the US Department of Education.

EXECUTIVE SUMMARY:

Four Maryland schools have been named winners of the inaugural National Green Ribbon School Award: Dunloggin Middle School (Howard County Public Schools), Folger McKinsey Elementary School (Anne Arundel County Public Schools), Francis Scott Key Middle School (Montgomery County Public Schools), and the Lucy School (nonpublic, Frederick County).

MSDE received 15 completed applications from public and non-public schools and nominated four schools, the maximum number allowed. All four schools nominated for the honor by MSDE received Green Ribbon recognition. Seventy-eight schools from 29 states and the District of Columbia received the honors. Maryland tied with California, New Jersey, Oregon, Pennsylvania, and Washington for the most schools recognized in the new program.

U.S. Education Secretary Arne Duncan, along with White House Council on Environmental Quality Chair Nancy Sutley, Environmental Protection Agency Administrator Lisa Jackson, and Surgeon General of the United States Regina M. Benjamin recognized the honorees during a ceremony and conference in Washington, D.C.

FOUR MARYLAND SCHOOLS RECEIVE NATIONAL GREEN RIBBON HONOR

FEDERAL OFFICIALS TAP ALL FOUR STATE NOMINEES FOR NEW RECOGNITION PROGRAM

BALTIMORE (April 23, 2012) – Four Maryland schools have been named winners of the inaugural Green Ribbon School Award: Dunloggin Middle School (Howard County Public Schools), Folger McKinsey Elementary School (Anne Arundel County Public Schools), Francis Scott Key Middle School (Montgomery County Public Schools), and the Lucy School (nonpublic, Frederick County).

U.S. Education Secretary Arne Duncan, along with White House Council on Environmental Quality Chair Nancy Sutley, and Environmental Protection Agency Administrator Lisa Jackson, announced the honorees in Washington, DC. Seventy-eight schools from 29 states and the District of Columbia received the honors.

All four schools nominated for the honor by MSDE received Green Ribbon recognition. State education agencies in 33 states, in collaboration with the U.S Department of Education, participated in the inaugural year of the GRS award program. MSDE received 15 completed applications from public and private schools and nominated the maximum number allowed based on the State's student population.

Maryland tied with California, New Jersey, Oregon, Pennsylvania, and Washington for the most schools recognized in the new program.

"Science and environmental education play a central role in providing children with a well-rounded education that prepares them for the jobs of the future," Secretary Duncan said. "Green Ribbon Schools demonstrate compelling examples of the ways schools can expand their coursework while also helping children build real world skill sets, cut school costs, and provide healthy learning environments."

Federal officials launched the award to recognize schools that save energy, reduce costs, feature environmentally sustainable learning spaces, protect health, foster wellness, and offer environmental education to boost academic achievement and community engagement.

"These awards shine a bright spotlight on Maryland schools, which have long been committed to environmental education and to practices that will strengthen our world for generations to come," said Interim State Superintendent Bernard J. Sadusky. "We congratulate our winning schools. They represent the first of many Maryland schools we expect to receive this honor in the coming years."
