PERMISSION TO PUBLISH

PURPOSE:

- To review proposed revisions to the Maryland Student Records System Manual (MSRSM) (ATTACHTMENT I), which is incorporated by reference with the regulations of the Maryland State Board of Education [Code of Maryland Regulations (COMAR) 13A.08.02.01]. The proposed revisions are presented as the result of concerns expressed by members of the Maryland State Board of Education during the June 21 Maryland State Board of Education meeting.
- The proposed amendments to COMAR 13A.08.02.01, COMAR 13A.08.01.01.E, and COMAR 13A.02.06.02B(9) that update references to the MSRSM (ATTACHMENT II).

BACKGROUND/HISTORICAL PERSPECTIVE:

The MSRSM was presented for permission to publish to the Maryland State Board of Education on June 21, 2011. Members of the State Board of Education expressed concerns regarding items in the Discipline section of the MSRSM as well as the race codes.

EXECUTIVE SUMMARY:

Changes in the Manual are proposed as a result of suggestions proposed by members of the Maryland State Board of Education. The following summarize the changes that were made:

E-13	Race Codes	The race codes were reviewed and were found to be correct. The law stipulates a two part question: one for Hispanic ethnicity and the second question for a racial category. Individuals that are Hispanic ethnicity must select a racial category, although they are only counted once in the Hispanic ethnicity category, not the racial category. Please note the Aggregate reporting requirements below.
		Individual Student response is a two part question: Part 1: Ethnicity Are you Hispanic/Latino? Yes No Part 2: Race

		Student level data is captured at the finest detail and can aggregate these data in 64 possible combinations (i.e. yes Hispanic, white and black), although the federal reporting requirement is 7 categories. The 64 possible combinations would only be produced based on a special request since currently the 7 required aggregate categories have been addressed. Hispanic is not a racial category in the federal law, but an ethnicity and will be reported separately in an unduplicated count.
