### MINUTES OF THE MARYLAND STATE BOARD OF EDUCATION

Tuesday July 21, 2009

Maryland State Board of Education 200 W. Baltimore Street Baltimore, Maryland 21201

The Maryland State Board of Education met in regular session on Tuesday, July 21, 2009, at the Nancy S. Grasmick State Education Building. The following members were in attendance: Mr. James H. DeGraffenreidt, Jr., President; Dr. Charlene M. Dukes; Dr. Mary Kay Finan; Dr. S. James Gates, Jr.; Mr. David H. Murray; Mrs. Madhu Sidhu; Mr. Guffrie M. Smith, Jr.; Donna Hill Staton, Esq.; Dr. Ivan Walks; Ms. Kate Walsh and Dr. Nancy S. Grasmick, Secretary/Treasurer and State Superintendent of Schools.

Elizabeth Kameen, Esq., Assistant Attorney General, and the following staff members were also present: Dr. John Smeallie, Deputy State Superintendent for Administration; Dr. Ronald Peiffer, Deputy State Superintendent for Academic Policy and Mr. Anthony South, Executive Director to the State Board.

### **CONSENT AGENDA**

The President welcomed the new Board members and asked if they would like to make brief remarks. He then explained the kinds of items that the Board's includes as part of the Consent Agenda and asked for approval of those items. He asked Dr. Grasmick to provide some additional background on the item on "permission to publish" amendments to COMAR references to the Voluntary State Curriculum.

Dr. Grasmick explained that a Visionary Panel created in 2002 looked at school reform efforts in Maryland and suggested that Maryland have statewide curricula due to vast financial inequities for small jurisdictions in obtaining experts to develop curricula. She said that now that the curriculum has been developed, it is now time to remove the word "voluntary" from state curriculum. She explained that every school system has embraced the Voluntary State Curricula (VSC). She described the curricula as "dynamic" rather than "static" since it will be monitored and evaluated regularly.

Mr. DeGraffenreidt reported that the *No Child Left Behind Act* (NCLB) requires the labeling of schools as "persistently dangerous" when certain criteria are met. He explained that previous Boards were uncomfortable with the designation and that the Board sent a letter last year to the federal Department of Education (USDE) seeking relief from the requirement. He introduced Mr. Jonathan Brice, Executive Director for Student Support for the Baltimore City Public Schools (BCPS) to answer any specific questions about the schools identified.

In response to a question by Ms. Walsh, Dr. Grasmick explained that the USDE has indicated that this designation is a national problem and will be dealt with during the reauthorization of the Elementary and Secondary Education Act (ESEA). She said she has had many conversations with the Secretary of Education and that USDE is very comfortable with the way in which Maryland is handling this matter.

In response to a question by Ms. Staton, Mr. Chuck Buckler, Director, Student Services and Alternative Programs Branch, described the process used to set the parameters for designating a school as "persistently dangerous." He explained that the offenses outlined in the parameters are very serious and based on incidents over three years. He reported that there have been very few students transferring to other schools as a result of the label but that the labeling focuses attention on the school in a positive way.

In response to a question by Dr. Gates, Mr. Buckler said that putting a school on probationary status may or may not have a positive effect on the school. Ms. Walsh proffered that the labeling has a negative impact since schools underreport offenses.

Mr. Brice explained that the school system is doing weekly reviews of every disciplinary action that occurs in the schools. He noted that a toll free number is being distributed for parents to report incidences to the school system. He reported that attendance is increasing and suspensions are down in the Baltimore City schools. Mr. Buckler said that the Department did an audit on the schools that have been designated and found no indication of undocumented suspensions.

Dr. Walks said that the most important issue for him is safety for students and that, if labeling a school helps to make it safer, he is in favor of the action. He applauded the efforts of the education community.

Ms. Walsh, once again, expressed her concern that the labeling of schools provides an incentive to underreport violent activity. Mr. Brice said that there are protocols in place which provide the school system with ways to identify if underreporting is taking place. He said they have found that this is not the case.

Mr. Buckler explained that the disciplinary actions on schools help to focus resources on that school. He also note that often times, students bring weapons to school because they feel the need to defend themselves on the way to school. He said it is difficult for schools to address all of the problems in the surrounding communities.

Dr. Grasmick explained that Baltimore City Schools Chief Andres Alonso has closed several schools based on the fact that they are deemed dangerous.

In response to a question by Dr. Gates, Mr. Brice said that collaboration with the MSDE and the Mayor's Office has been very helpful but that the real work is with the school community and schools led by great principals. He noted that the school system is working with the Baltimore Police Department to provide safe passage for students traveling to schools.

Mr. Smith said, "Intervention is the key. It's a comprehensive effort."

Mr. Brice explained that putting new leaders in the schools and providing early identification and strategies for students in need is the focus at this time.

Mr. DeGraffenreidt said that he feels the Department would lose credibility if it changed paths at this time and reminded Board members that the objective is to provide great, safe schools.

Upon motion by Dr. Walks, seconded by Mr. Smith, and with unanimous agreement, the Board approved the Consent Agenda as follows: (In Favor -10)

### <u>ALTERNATIVE GOVERNANCE PROPOSAL—HARFORD COUNTY PUBLIC</u> SCHOOLS (HCPS)

Dr. Grasmick reported that the Board has previously been asked to review and approve the Alternative Governance proposals for seven schools during this school year. She reported that Dr. Robert Tombeck, Superintendent of the Harford County Public Schools, and several of his staff members, were present to discuss the Alternative Governance proposal for the Center for Alternative Education in Harford County. She also invited Ms. Ann Chafin, Assistant State Superintendent, Division of Student, Family and School Support and Ms. Teresa Knott, Supervising Coordinator, School Performance, to provide background information on the process for the benefit of the new Board members. She recommended approval of the Alternative Governance Proposal for the Center for Alternative Education in Harford County.

Ms. Chafin explained that the NCLB Act requires that schools go through a year-long process for improvement if they are found not to make the required *Adequate Yearly Progress* (AYP). She noted that the MSDE is the only Department in the nation that brings its restructuring plans to the State Board for approval and the goal of the Department is to get schools out of needing improvement status.

Ms. Knott explained that Department staff work with the leaders in the schools that do not meet AYP. She explained the three options available to the school systems and noted that this year all of the school systems selected Option 1, *Replace all of most of the school staff, which may include the principal, who are relevant to the school's inability to make adequate progress.* Ms. Knott discussed the strategies used in the schools last year and noted changes to the master schedules and the enhancement of disciplinary guidelines in the designated schools. She explained that the Center for Alternative Education did not meet graduation requirement for AYP but did very well in meeting AYP in reading and mathematics. She noted that the Harford County Board of Education and Superintendent of HCPS have approved this Alternative Governance proposal.

Dr. Tombeck introduced staff members Roger Plunkett, Assistant Superintendent for Curriculum & Instruction and David Volrath, Director of Secondary Education. He explained that the students attending this school are the neediest students in the County. He reported that the school includes voluntary students and involuntary/suspended students who are provided day and night school programs. Superintendent Tombeck explained that the enrollment in the school varies greatly during the year since many students will return to their home school after participating in the Center's Program. He said that many of these students are not on track for graduation when they enter high school and that the school provides wrap-around services to them including academic, social/behavioral, and mental health services. He provided data on the successes of the school and the graduation rates for the period 2005-2009. Mr. Tombeck went over the five action steps in the proposal as well as the staffing changes.

In response to a question by Mr. DeGraffenreidt, Mr. Tombeck explained that graduation rates are calculated on the student enrollment on June 1 of the school year.

In response to a question by Ms. Walsh, Dr. Grasmick said that this school is held to the same standards as other Maryland schools because of the rigidity of the NCLB. She said she anticipates that the reauthorization of ESEA may change this ruling.

In response to another question by Ms. Walsh, Mr. Plunkett explained that the Harford County Board made the decision to designate June 1<sup>st</sup> as the cut-off for determining the graduation rate since any other option would have adversely affected several other schools. Dr. Grasmick reiterated that there should be an exception for this school and noted that the problem will continue to grow in Maryland.

Dr. Walks said he would like to see how other school systems in Maryland deal with these student populations in meeting AYP goals.

Dr. Gates congratulated the presenters and commended them on their excellent planning efforts.

Upon motion by Dr. Gates, seconded by Dr. Dukes, and with unanimous agreement, the Board approved the Alternative Governance Proposal for the Center for Alternative Education in Harford County. (In Favor -10)

## MARYLAND TEACHER PROFESSIONAL DEVELOPMENT ADVISORY COUNCIL REPORT

Dr. Grasmick explained that she convened the Maryland Teacher Professional Development Advisory Council in January 2003 to examine the state of the art of teacher professional development and to offer recommendations for how the Department can work with other stakeholders to improve the quality and effectiveness of professional development opportunities afforded to teachers and those entering teaching in Maryland. She introduced Dr. Colleen Seremet, Assistant State Superintendent, Division of Instruction and Co-Chair of the Advisory Council, along with Dr. Bruce Haslam of Policy Development Associates who provided advice and guidance to the Council since its inception to brief the Board on the work of the Council and

share the highlights of the Council's fourth report. She recommended acceptance of the fourth and final report of the Maryland Teacher Professional Development Advisory Council.

Dr. Seremet recognized the contributions of Dr. Jackie Haas, former Superintendent of the Harford County Schools, as Co-Chair of the Council, until her recent untimely death this past December. Dr. Seremet reported on the work done by the Council to create thirteen recommendations with thirty-three action steps to be used as a roadmap for school systems to provide high quality professional development to their staff.

Dr. Haslam explained that the recommendations fell into the following four areas:

- 1. Maryland programs to support new teachers
- 2. Finding time for teacher engagement in high-quality professional development
- 3. Understanding the contributions of teacher enrollment in college and university courses to professional knowledge and skills
- 4. Establishing a system of high-quality professional development

In response to Mr. DeGraffenreidt's question, "Is there any information that speaks to how you measure the success of the recommendations and the effects on student performance?" Dr. Haslam said there are some efforts underway now to develop a guide to measure the effectiveness of these recommendations. He said there is some serious capacity-building to be done in the school districts. Dr. Seremet noted that this has been included in the Master Plan requirements and that the Department is working on this issue.

Dr. Finan suggested that the unique teacher identifier can be helpful in evaluating the professional development programs. Dr. Seremet said that a longitudinal data base will also be very effective in this area.

In response to a question by Ms. Staton, Dr. Seremet said that school districts will be providing the Board with information on specific professional development programs. Dr. Grasmick said that the Master Planning process requires strategies for achievement and that it is the key process for ensuring that high quality professional development is taking place.

Dr. Gates suggested that college accreditation courses include professional development programs. Dr. Haslam said, "The Council is weighing what's possible."

In response to a question by Dr. Dukes, Dr. Seremet said that the MSDE provides direct professional development programs as well as technical assistance and training of local school system personnel on how to provide high quality professional development programs for their teachers.

In response to a question by Dr. Walks, Dr. Seremet said that the recommendations require school districts and the Department to make difficult choices with limited resources to provide professional development.

Upon motion by Ms. Staton, seconded by Dr. Finan, and with unanimous agreement, the Board accepted the Report of the Maryland Teacher Professional Development Advisory Council. (In Favor -10)

### 2009 MARYLAND SCHOOL ASSESSMENT RESULTS

Dr. Grasmick invited Dr. Leslie Wilson, Assistant State Superintendent, Division of Assessment and Accountability, to provide the Board with an in-depth look at the results of the 2009 administration of the Maryland School Assessments (MSAs). She said the results provide concrete evidence of the growth in student performance that has been achieved across Maryland since 2003. She commended Dr. Wilson for her diligence and extraordinary work explaining that there are many states where the results must be withdrawn because there are many flaws in the data collection. Dr. Grasmick said that the accuracy in Maryland is attributable to Dr. Wilson and her excellent staff.

Dr. Wilson reported that, due to a power failure, access to the final MSA results on the MSDE website will be delayed to the public. She reported that more than 364,000 students were tested and described the process followed to collect and compare the data for new Board members. She reported that the third grade cohort of students has continued to rise in reading and mathematics. Dr. Wilson noted the impact of early learning efforts on third grade results, the positive effect of the state curriculum, the cumulative impact of the Bridge to Excellence in Education funding on teaching and learning and the growth in the percentage of Highly Qualified Teachers in place in the public schools in Maryland.

In reporting the gains made in all elementary and middle schools in reading and mathematics, Dr. Wilson stated that it is getting harder to continue making this kind of progress. She said that the progress made in the middle schools can be attributed to the improvements made previously at the elementary school level. She provided data that showed that all service groups have made gains and provided graphs depicting the closing of achievement gaps for these students.

Dr. Wilson explained how Adequate Yearly Progress (AYP) is determined, the challenges to achieving AYP, the school improvement categories and provided the AYP results for the 2009 school year.

In response to a question by Dr. Gates, Dr. Wilson explained that an article in the newspaper about how Maryland is lagging behind Virginia in closing achievement gaps is based on data gathered from the National Assessment of Educational Progress (NAEP). She went on to say NAEP results reflect a very small sampling of students, approximately 2500 in Maryland. She explained that the purpose of the Maryland School Assessment is very different from that of the NAEP.

In response to concerns raised by Ms. Walsh regarding Maryland's performance on the NAEP, Dr. Grasmick said that she wished Ms. Walsh had been present to hear Dr. Treisman's (professor of mathematics and public affairs at the University of Texas) address at the University of Maryland at which he praised Maryland's performance on NAEP. She then distributed a paper

prepared by the Department on Maryland's NAEP results. She said that the impression that Maryland performs at low levels on NAEP is inaccurate and she wanted them to read this paper that helps summarize where we really are. She also said that NAEP is not comparable to MSA since there are no stakes or feedback to teachers, schools, or students on how they do.

In response to a question by Ms. Walsh, Dr. Wilson reported that performance level descriptors are posted on the Department's website and that the adoption of national standards will prove very helpful in comparing the results among all the States.

In response to a question by Ms. Staton, Dr. Grasmick explained that the drop in achievement by students from elementary to middle school is a difficult issue and that she convened a Middle School Task Force to look at the issue. Dr. Seremet, Chair of the Task Force, said that the Task Force recommended separate middle school teacher programs. She said that the Task Force found that the unique educational needs of students in middle schools shows that engagement of those students is critical.

In response to a question by Dr. Gates, Dr. Grasmick said that she will provide the Board with information on the misalignment between the test results of the NAEP and MSA as well as other international benchmarking assessments.

### STATE SUPERINTENDENT'S UPDATE

The Superintendent reported that Maryland was the only State to receive a competitive grant of \$14.4 million to provide services to children in the Infants and Toddlers Program.

She reported on a Summit on Autism held which reported that the number of children with autism in Maryland has jumped from 253 to more 8000.

Dr. Grasmick distributed the Department's new *Guide to Implementing and Monitoring Wellness Policies in Maryland* and reported that it is available on the Department's website as well.

She also reported on a conference held in Maryland by the National Association of School Resource Officers. School resource officers are police officers who live in and monitor schools.

### **EXECUTIVE SESSION**

Pursuant to §10-503(a)(1)(i) & (iii) and §10-508(a)(1),(7), of the State Government Article, Annotated Code of Maryland, and upon motion by Dr. Walks, seconded by Mrs. Sidhu, and with unanimous agreement, the Maryland State Board of Education met in closed session on Tuesday, July 21, 2009, in Conference Room 1, 8<sup>th</sup> floor, at the Nancy S. Grasmick State Education Building. All board members were present. In attendance were Dr. Grasmick, State Superintendent of Schools; Dr. John Smeallie, Deputy State Superintendent for Administration; Dr. Ronald Peiffer, Deputy State Superintendent for Academic Policy; and Tony South, Executive Director to the State Board. Assistant Attorneys General, Elizabeth M. Kameen and

Jackie La Fiandra were also present. The Executive Session commenced at 1:25 p.m. (In favor – 10)

The Board also received legal advice on the status of the Maintenance of Effort appeal and on the executive privilege governing the confidentiality of the budget.

Steve Brooks, Robert Crawford, and David Susio explained the FY 2011 Budget Proposal and answered the Board's questions. The Board also discussed two internal management issues - proposed meeting dates for 2010; the process for identifying candidates for Baltimore City Board of School Commissioners.

At 3:35 p.m. all staff left the meeting. The Board nominated candidates for State Board President and Vice President.

The Executive Session ended at 3:40 p.m.

### RECONVENE

The meeting reconvened at 3:45 p.m.

### **ELECTION OF OFFICERS**

Ms. Kameen explained that State statute requires that the State Board hold an annual meeting in July and that, at this meeting, the Board is required to elect officers from among its members.

She then asked for nominations for the position of President of the Board. Dr. Finan nominated Mr. James DeGraffenreidt for President.

Upon motion by Dr. Finan, seconded by Ms. Staton, and with unanimous agreement, the Board elected Mr. DeGraffenreidt as President. (In Favor – 10)

The President thanked the Board members for their support and said, "I am privileged to serve."

The President nominated Dr. Charlene Dukes as Vice-President of the Board. Upon motion by Mr. DeGraffenreidt, seconded by Ms. Staton, and with unanimous agreement, the Board elected Dr. Dukes as Vice-President. (In Favor -10)
